Moving Up to the Next Class

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for a Novice title, provided that request is made to the Trial Secretary in writing no later than the Monday before the trial. Move-ups over the weekend will be accommodated, provided the information is provided **within 15 minutes after the applicable class of the preceding trial concludes.**

DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

First entry (includes a \$3.50 AKC recording & service fee).....	\$25

DON'T FORGET THAT THERE ARE THREE TRIALS. If you enter one class in all three trials, your entry fee would be \$25 per trial, for \$75. If you enter the same dog in two classes in each trial, your fee would be \$40 per trial, for \$120. If you enter the same dog in three classes in each trial, your fee would be \$50 per trial, for \$150.

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry.

Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

WAIT LIST INFORMATION

Memphis Kennel Club is not offering a wait list. All entries, must be received by the Trial Secretary prior to **05/17/18**. No entries may be withdrawn with a refund after closing on 05/17/18.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

If entries allow enough space, a **warm-up area** will be available consisting of ONE container of Birch and may also consist of blanks containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior their run. The warm-up area is not for training or relieving of the dog.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors, on matted, carpeted, dirt, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

Search Area Sizes will be as follows, Container Novice (250-400sqft.), Interior Novice (100-200sqft.), Exterior Novice (200-400sqft.) Buried Novice (150-200sqft.) Container Advanced (400 - 600 sq. ft.), Interior Advanced (200 - 400 sq. ft.), and Buried Advanced (150-200 sq. ft.)

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 26 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be asked to leave the area by the judge. Spectators are forbidden to discuss details of the search with handlers who have not run.

Crating - Please crate in your vehicle for this event. Do not leave anything at the event site overnight. Please bring water for your dog(s).

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds. **Please come prepared with shade and water for your dogs.**

Concessions: No concessions will be available at the trial location and there are no meal options in close proximity. Exhibitors are advised to bring their own lunch, snacks and beverages.

RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

A **New Title rosette** will be awarded to all dog and handler teams finishing a title.

All exhibitors should obtain a copy of the Regulations for Scent Work Trials by downloading them from the American Kennel Club website.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. Nothing may be hanging from the dog's collar or harness, except that a wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email.

Exhibitors MUST check-in EACH day they are entered.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."

Overnight RV Parking/Camping is not available on the show site.

HOTELS THAT ACCEPT DOGS

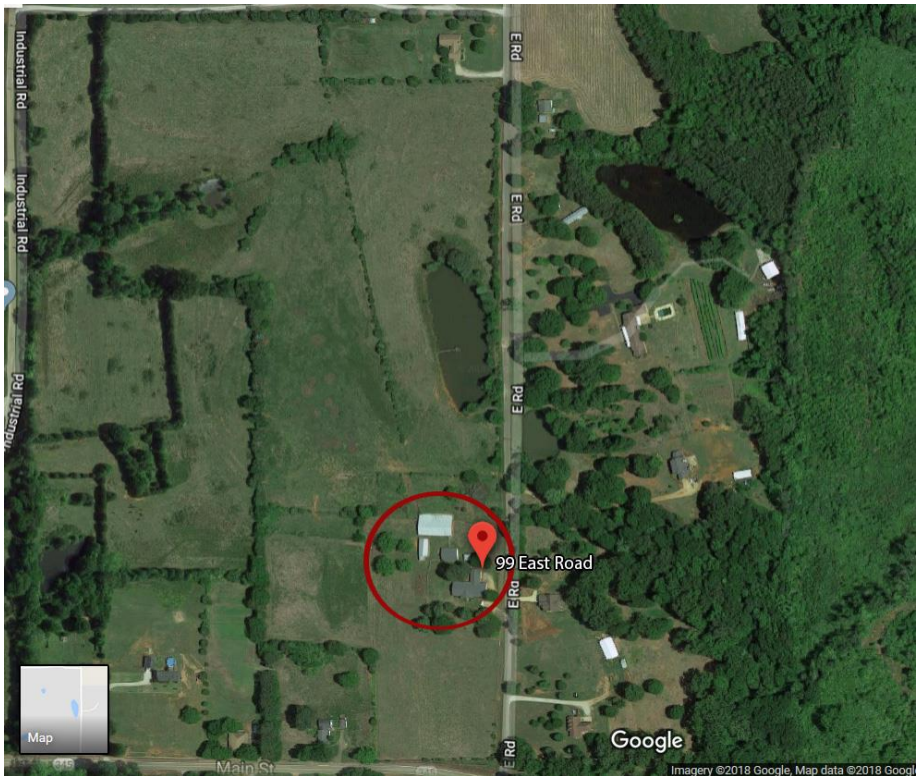
DIRECTIONS TO THE TRIAL SITE

Event Location Event location is the residence circled in the map below, located on East Road in Ecu MS.

Directions from the West: Head southeast on I-22. Take exit 64 for MS-15/MS-30 toward Pontotoc/Ripley and turn right to MS-15 and go 6 miles. Turn left on Co Rd 106 then continue onto Old Hwy 1 and go 1 mile. Then turn left on North Road and drive 0.9 mile. Then turn right on East Road and go 0.8miles to destination.

Directions from the East: From I-22/US 78 W towards Memphis, take exit 76 for MS-9 South toward Sherman/Pontotoc and turn left to MS-9 S/3rd Ave. Turn right onto old Hwy 9 and travel 5.9miles. Turn right onto Center Hill Rd and travel 4.9miles. Take a slight right onto Main St/MS-345 N. After 1 mile, Turn right onto East road. Destination is .2 miles on the left.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
